#### ARRIVAL AND DEPARTURE

Swiss nationals travelling to Argentina with a valid passport do not require an entry visa. A tourist visa allows them to stay for 90 days, which can be extended to 180 days.

Transfer from the airport to the city center:

- **Transfer service:** You can hire a vehicle for 3 people at USD23.00, in a door-to-door service
- **Taxis :** Taxis and taxis outside the arrival areas. Fare to center: USD30.00-38.00
- **Estimated travel time:** around 45 minutes. Uber and Cabify (USD15.00-18.00) in the parking lots.
- **Bus Service:** Shuttle Manuel Tienda León: 50 minutes to Terminal Madero and 80 min. to Aeroparque Jorge Newbery. Ticket offices in the public arrivals sector and the baggage claim hall. USD 8/10 ride from Ezeiza to Buenos Aires city center. Neo Transfers is another company that offers a similar service.

#### HEALTH REQUIREMENTS

No vaccination requirements for international travelers.

#### PUBLIC SECURITY / RECOMMENDED PRECAUTIONS

Argentina is generally a safe destination for travelers and foreign residents, but as anywhere, it is important to take precautions to ensure your safety. The following are specific recommendations:

**Street safety:** Keep your personal belongings at sight at all times, especially in crowded areas such as public transport, markets and tourist sites. Avoid displaying valuables such as jewelry, expensive watches, cell phones or electronic devices in public.

**Use of transport:** Use official taxis (yellow and black) or reliable app-based transport services (such as Uber or Cabify). Avoid boarding unlicensed taxis on the street. On public transport, watch out for pickpockets, especially during rush hour.

**Areas to avoid:** Some outlying areas of large cities, such as certain areas in the Buenos Aires suburbs, may be less safe, especially at night. Check with local residents or tourist guides to identify safe areas.

**Protests and demonstrations:** Demonstrations sometimes happen in Argentina, especially in central areas of Buenos Aires and other large cities. Although generally peaceful, they can disrupt traffic and occasionally generate tension. Avoid getting involved and stay informed about possible street closures.

**Money and transactions:** Prefer the use of credit cards in well-known businesses. If you need to withdraw cash, use ATMs in safe places such as banks or shopping centers.

## METHODS OF PAYMENT

National currency in Argentina is the Peso (ARS, \$). Although the peso is the official currency, US dollars (USD) are widely accepted for high-value transactions, particularly in real estate, tourist services and private rentals. However, for regular transactions in shops, restaurants or transportation, payments are usually made in pesos.

Exchange rate as of March 14, 2025: CHF 1 = ARS \$ 1.204,60

When entering or leaving the country with USD 10,000 (or its equivalent in other currencies) or more in cash or monetary instruments, travelers must declare the amount in writing to customs upon arrival or departure.

Tipping is usual in Argentina. Restaurants: It is customary to tip 10% of the total bill. Taxis: Passengers often round up the fare to the nearest peso as a tip. Hotels: Doormen and housekeeping staff may be tipped at your discretion, usually between ARS \$1000 and \$5000 depending on the service.

### Additional notes

**Cash (ARS):** Cash is widely accepted and preferred in small businesses and rural areas.

**Credit cards:** Visa, MasterCard and American Express are commonly accepted, especially in cities and tourist areas. Some establishments may charge a surcharge for card payments or set a minimum purchase amount.

**Foreign Currency (USD):** US dollars are accepted at hotels, tourist agencies or high-value private transactions. Always confirm in advance.

**Mobile payments:** Digital wallets such as Mercado Pago are commonly used among locals, but may not be accessible to foreign visitors.

## DOMESTIC TRAVEL, LOCAL TRANSPORT

The most frequently used kind of public transport are buses, trains and subways. The system works relatively well for daily commutes, but travelers should expect occasional delays and overcrowding.

Taxi fare for a 15 minute journey: Taxi fares include a base fare and a charge per kilometer or time. The base fare in Buenos Aires starts at ARS \$1920 (during the day) or ARS \$2300 (during the night, from 10 pm to 6 am). Ridesharing services such as Uber or Cabify are also available and can offer more competitive prices. Main apps: Cabify and UBER.

The main method of payment for taxis is cash. Subways, trains and buses the SUBE card is used. SUBE card is a prepaid card from which you can pay for the fare on different forms of public transport. The easiest way to buy it is through the official website, [www.argentina.gob.ar/sube](http://www.argentina.gob.ar/sube), at a cost of \$1500 (Argentine pesos). To obtain it, you must first complete the form with your personal information on the website. Then, choose where to receive it, you can choose free shipping to a SUBE Service Center, or have it sent at your home. Once you have selected the delivery method, make the payment electronically. Afterwards, you will receive an email with the purchase confirmation and the electronic invoice. Finally, pick up your card at the agreed location or receive it at your home. If you use SUBE Digital, you can easily pay for your ticket. Just tell the driver your travel destination, activate the NFC on your cell phone and bring it close to the validator with the screen on. Wait a few seconds for the payment to be processed.

Traffic conditions and waiting times may increase the fare.

## ACCOMMODATION, TEMPORARY OFFICE SPACE

### Accommodation

Argentina offers a wide range of accommodation options suitable for short and long stays, catering to different budgets and preferences:

Hotels: Budget accommodations range from USD 30-50 per night, while luxury hotels range from USD from USD300 to USD900 or more per night,

Alvear Palace Hotel/Palacio Duhau/Casa Lucía/ Four Seasons: Well-known luxury hotels. Rates start at USD 500 per night.

Short-term rentals: Platforms such as Airbnb and local agencies offer furnished flats and houses for short stays. Prices vary according to location, size and amenities, with costs ranging from USD 50 to USD 120 per night for a centrally located flat in Buenos Aires.

Extended-stay residences: Serviced flats are ideal for longer visits, offering amenities such as basic cooking and cleaning services.

Temporary office space: Short-term office rentals are available in major cities and business centers: Serviced offices: Business centers and serviced office providers, such as Regus, WeWork, offer private offices with meeting rooms, internet and administrative support. Customized options: Temporary office facilities can also be arranged through real estate agencies or local business networks.

**Additional notes:**

Location matters: Accommodation and office space in central business districts or tourist areas tend to be expensive.

Booking in advance: It is advisable to book in advance, especially during peak tourist seasons (December-March and July).

Utilities and internet: Both accommodation and office space usually include high-speed internet, although connectivity may not be good in rural areas.

**Scheduling Meetings:**

The business day usually starts at 9 a.m. Appointments must always be made in advance and punctuality is important.

**Business attire:**

It is customary to wear a suit and tie, for men. For more informal meetings you may not wear a tie.

Women wear business jackets either with a dress, pants or a skirt.

**Introducing yourself:** Men greet each other with a handshake and women with a kiss on the cheek.

Meetings usually begin with informal small talk and eye contact is important. Business is generally conducted in a relatively formal manner, although titles have become more relaxed and the use of first names is common. Argentines tend to use the informal "vos" as opposed to the more formal "usted".

**Building trust and personal relationships:**

Establish personal connections, be polite and respectful, be patient and flexible to local timing, demonstrate your commitment and embrace the local culture is crucial

**Offering and accepting gifts and invitations:**

Gift-giving in Argentina is a gesture of respect but should remain professional. Accept gifts graciously, expressing thanks. Inviting for meals is common and a good way to build connection. It's important to extend the invitation politely and with enough notice. When accepting invitations, be punctual, dress appropriately, and show gratitude for the opportunity.

**Sensitive topics:**

In general, Argentinians are friendly and enjoy open, passionate conversations, but being mindful of sensitive such as: the Military Government, the Malvinas War, current political climate, economic struggles and soccer rivalries. This will help you navigate social and business interactions with respect and understanding.

## BUSINESS RISKS

**Corruption:** Corruption remains a problem in Argentina, particularly in relations with the public administration and procurement processes. According to <https://risk-indexes.com/global-corruption-index/>, Argentina faces medium to high risks in this area.

**Legal certainty:** The legal framework in Argentina is complex and regulations change frequently. It is advisable to engage local legal counsel to address contractual and compliance issues.

**Taxation and bureaucracy:** The tax system is complex, with multiple levels of national, provincial and municipal taxes. Administrative processes can be time-consuming and require proper planning and local expertise. VAT is 21%, refundable for tourists at large shops.

**Labor regulations:** Labor laws in Argentina are strict and provide protection for employees. Companies should be aware of these regulations and ensure compliance to avoid disputes or sanctions.

**CCR risk rating:** Argentina's credit risk rating can be consulted on the official SERV website: Risk Rating <https://www.serv-ch.com/en>.

### Recommendations to mitigate risks:

- Conduct thorough background checks on partners and suppliers. Contact Swiss Argentine Chamber of Commerce.
- Establish clear and transparent contracts to mitigate legal uncertainties.
- Use financial instruments such as forward contracts or dollar-linked accounts to reduce foreign exchange risks.
- Leverage local expertise to navigate regulations, taxes and labor laws.

## IMPORT OF SAMPLES AND CATALOGUES

### Temporary Importation of Samples and Catalogues

ATA Carnet: Argentina does not participate in the ATA Carnet system, so commercial samples must go through the usual customs formalities, including any duties or bonds refundable upon re-export.

Customs duties on samples: Non-commercial samples (e.g. marked or unusable items) may be imported duty free if labelled as 'samples of no commercial value'. Commercial samples may incur customs duties depending on their declared value.

Customs duties on catalogues: Small quantities of catalogues for non-commercial use may be duty free, but larger consignments for distribution may be subject to import duties.

## Additional considerations

Documentation requirements: A detailed invoice or declaration specifying the purpose, value and nature of the goods is essential to facilitate customs clearance.

Inspection: Customs may inspect shipments to ensure compliance and verify eligibility for duty exemptions.

Time limits: Temporary imports must be re-exported within the time limit set by Customs, depending on the destination and nature of the goods.

## Recommendations

Consult with Argentine customs or a local agent for specific regulations and to ensure proper labelling and documentation to avoid delays.
